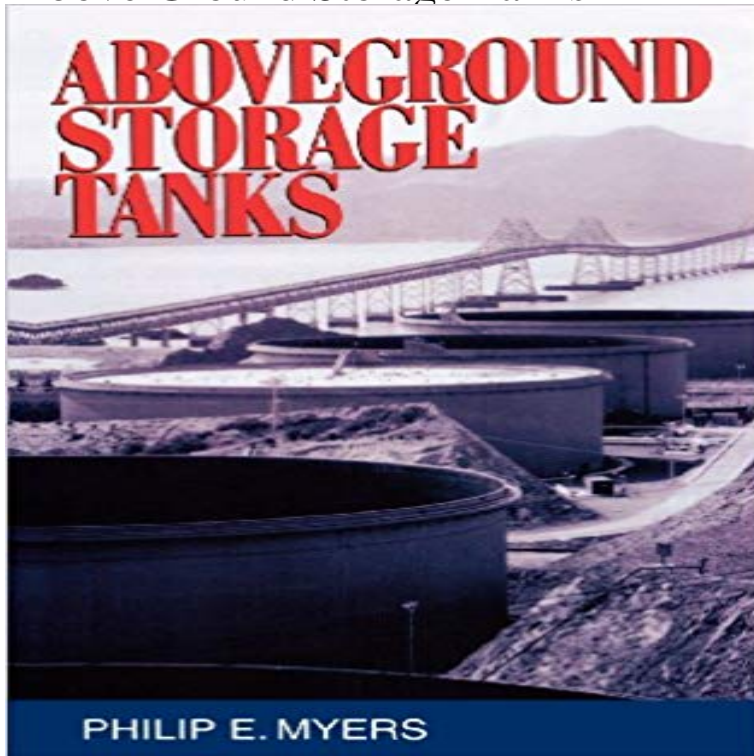


## Above Ground Storage Tanks
