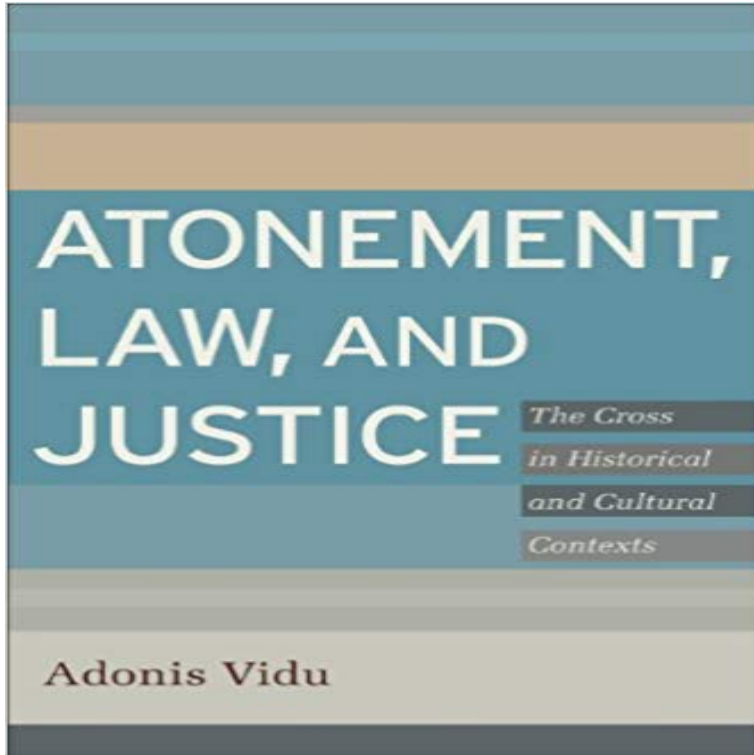


# Atonement, Law, and Justice: The Cross in Historical and Cultural Contexts
