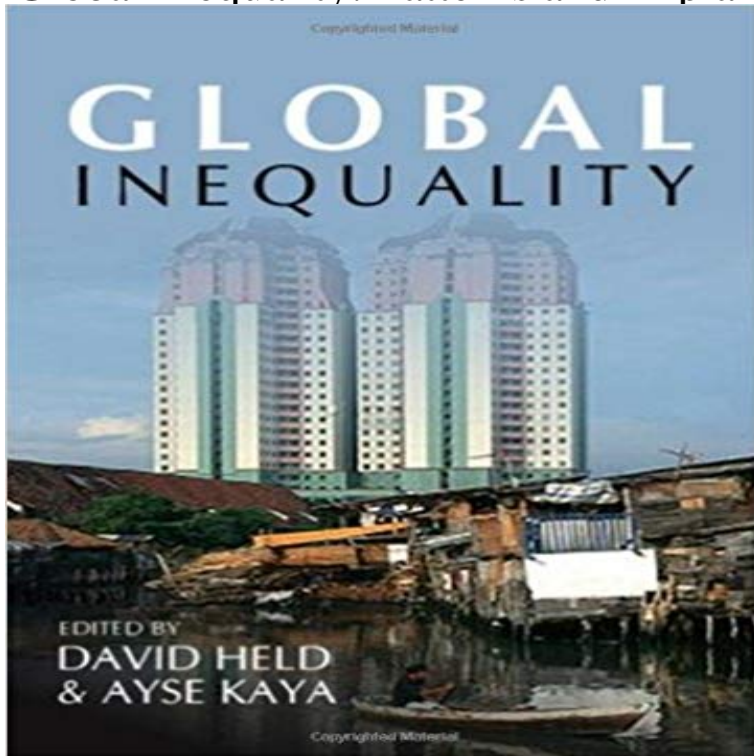


## Global Inequality: Patterns and Explanations
