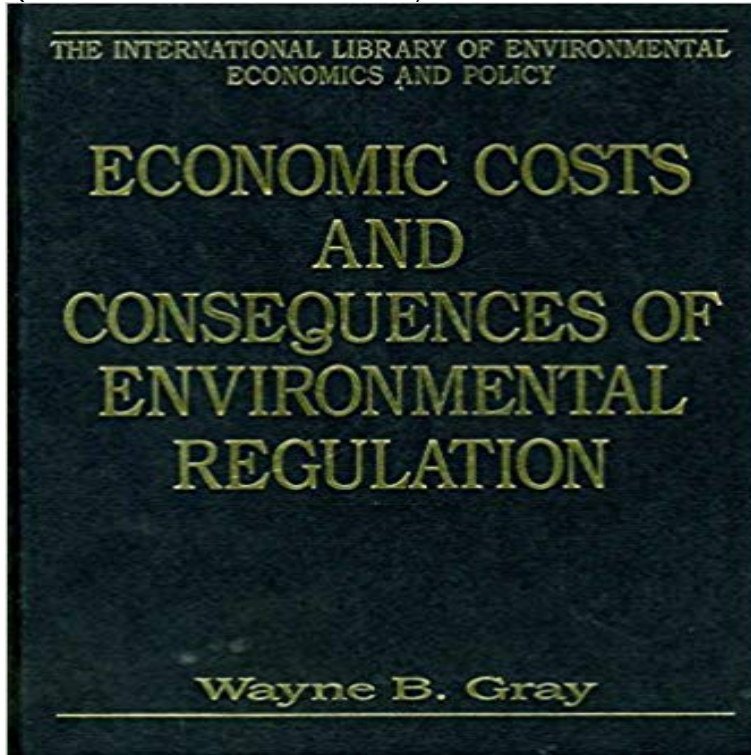


# Economic Costs and Consequences of Environmental Regulation (International Library of Environmental Economics and Policy)
