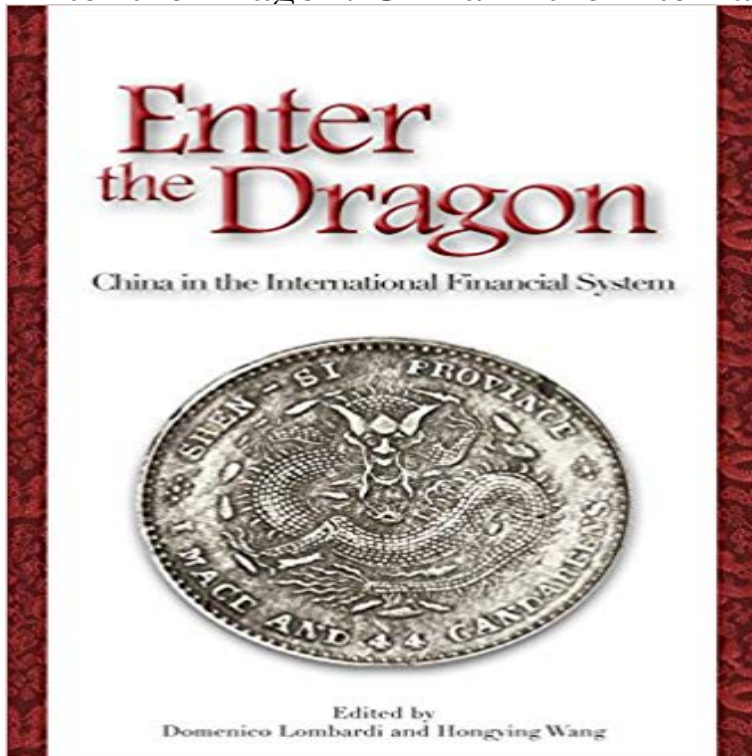


Enter the Dragon: China in the International Financial System



English summary: The dichotomy between consent and constraint has dominated scholarship on popular involvement in the First World War. The present collection of articles complicates the question, drawing on the terms accept, endure, and refuse, nuancing the participation of individuals, collectives, and states in the Great War.

French description: La dichotomie entre consentement et contrainte a pris une certaine importance dans les debats recents portant sur lexperience des societes pendant la Premiere Guerre mondiale. Cet ouvrage a pour ambition de reformuler la problematique de lengagement des populations dans le conflit a travers une approche renouvelee. Il depasse les oppositions trop rigides entre consensus sur la guerre et rejet de celle-ci, considerant que les populations, tant civiles que militaires, ne se reduisent pas a des elements passifs mais gardent leur capacite de reaction autonome. Aussi propose-t-il une terminologie ternaire pour aborder les experiences des peuples en guerre - accepter, endurer, refuser. Le terme moyen, endurer , permet dexplorer toute la complexite dun conflit qui defie les previsions et dont le prix en vies et souffrances remet en cause la question du rapport entre les fins et les moyens. Il ne sagit pas, toutefois, de presenter une evolution successive dun terme a lautre - de lacceptation a lendurance, avant den arriver au refus. Car tout depend des multiples sens de chaque terme, et du chevauchement possible des differentes reactions. Ces trois termes offrent plusieurs avantages sur une echelle qui va de lindividuel au collectif. Ils se pretent a la prise en compte de limaginaire de la guerre et des multiples discours qui laccompagnent. Ils permettent egalement dexaminer ou, quand et comment le refus prend le dessus sur lendurance par rapport aux societes ou lendurance sappuie jusqu a la fin sur une acceptation du conflit - et ce

malgré son caractère inexorable. Cet ouvrage, fondé sur des travaux originaux suscités par le Centre international de recherche de l'Historial de la Grande Guerre, à Peronne, réunit des historiens européens et américains, parmi les meilleurs spécialistes internationaux de la Première Guerre mondiale. Par sa focale authentiquement internationale, son attention est portée au front oriental autant qu'occidental, il transcende les débats étroitement nationaux.
