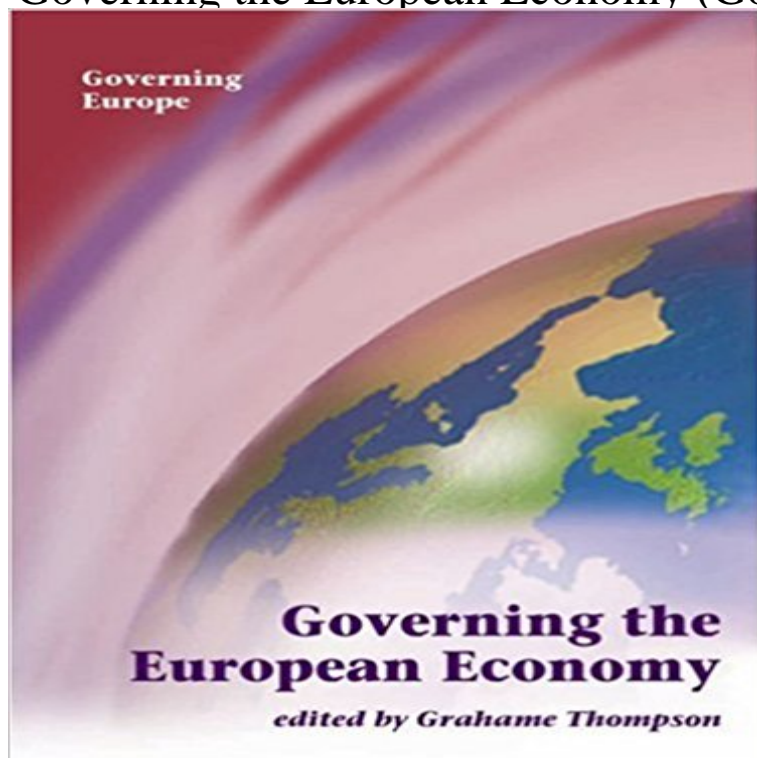


Governing the European Economy (Governing Europe series)
