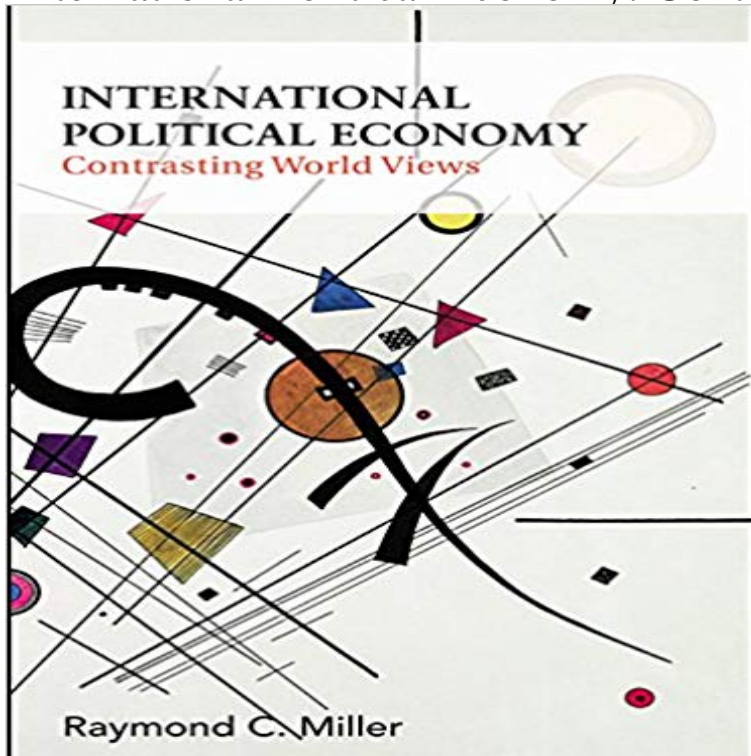


International Political Economy: Contrasting World Views
