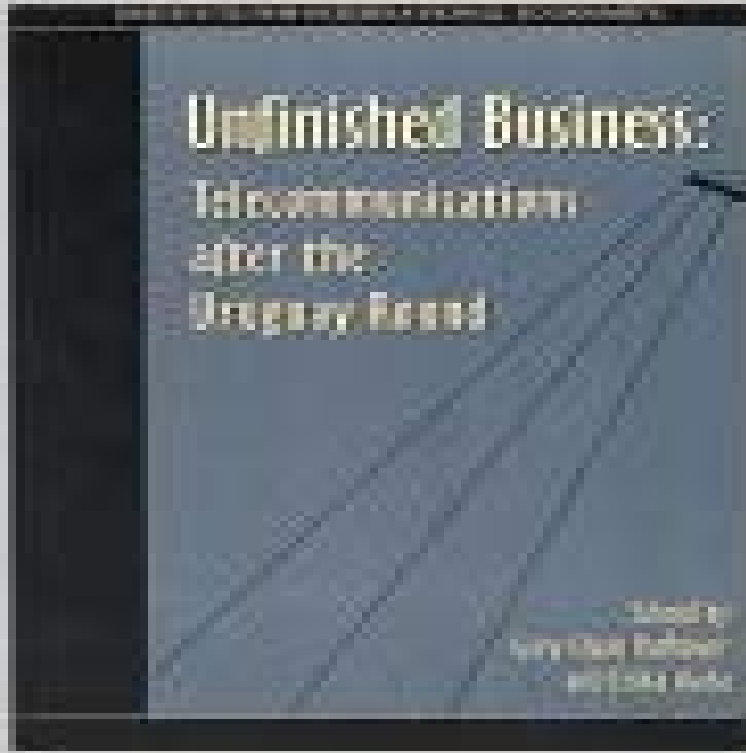


# Unfinished Business: Telecommunications After the Uruguay Round
