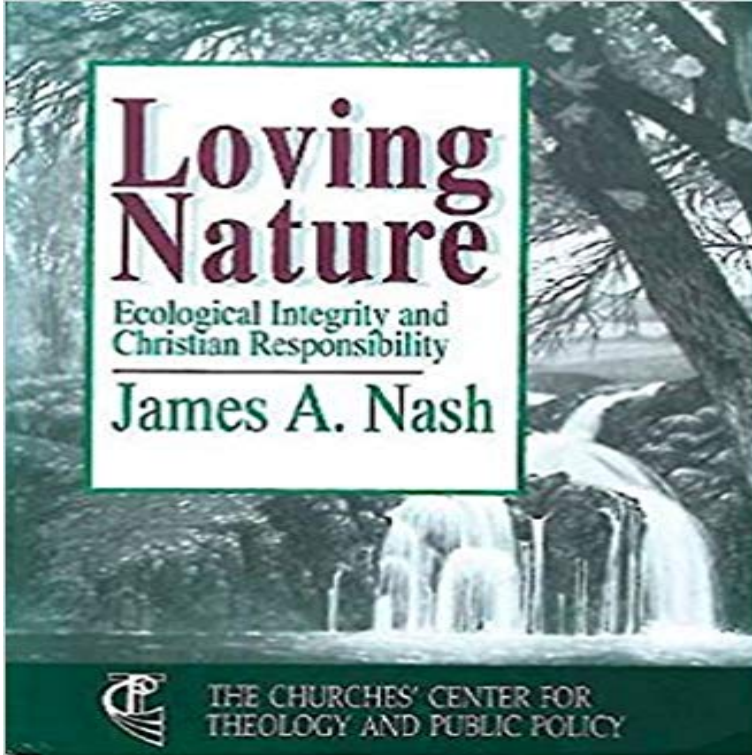


Loving Nature: Ecological Integrity and Christian Responsibility (Churches Center for Theology and Public Policy)
