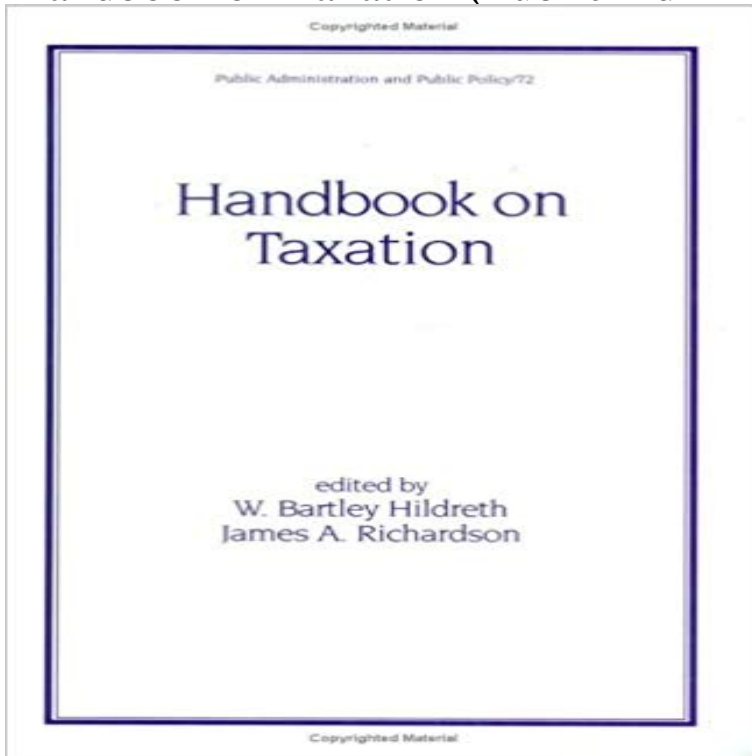


Handbook on Taxation (Public Administration and Public Policy)
