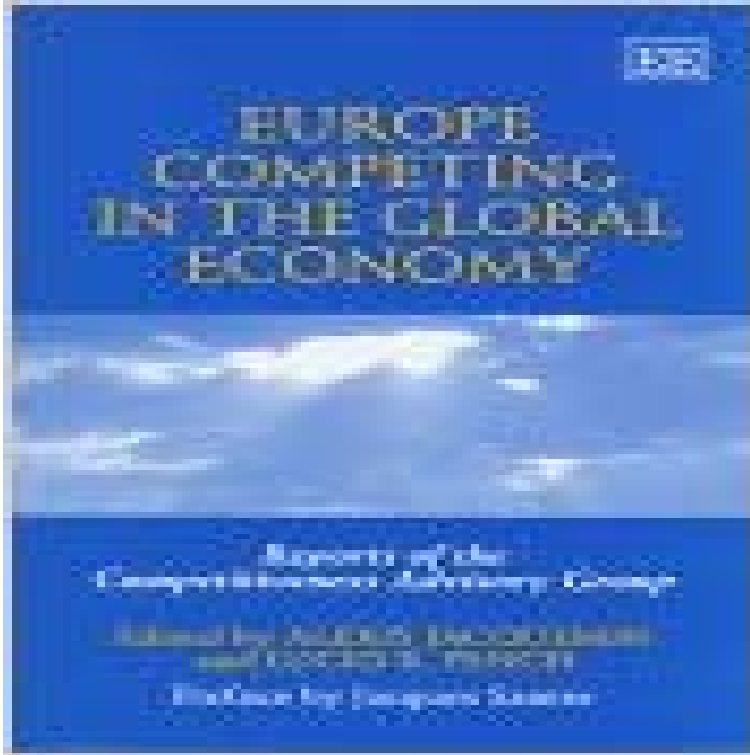


Europe Competing in the Global Economy: Reports of the Competitiveness Advisory Group
