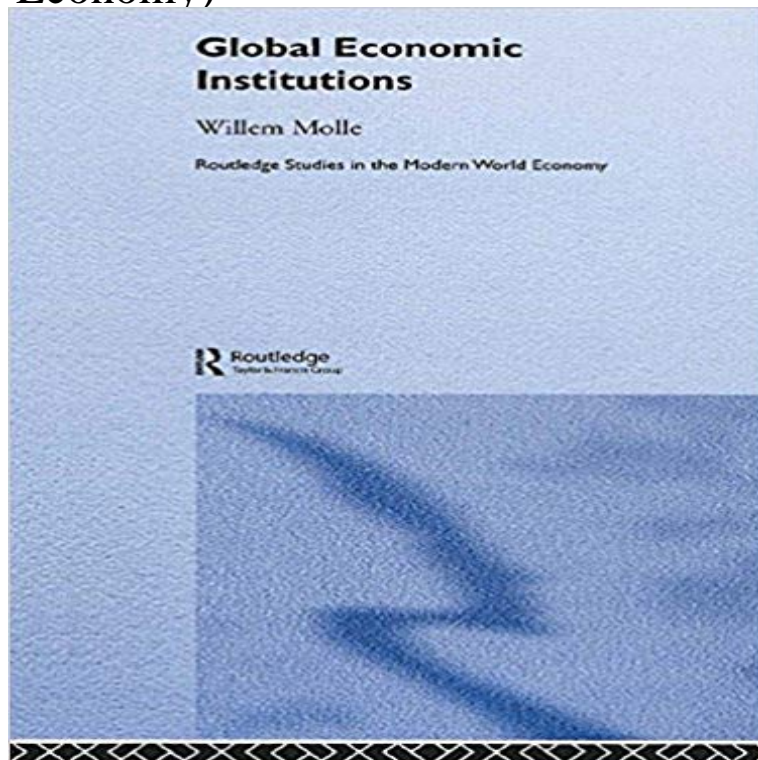


Global Economic Institutions (Routledge Studies in the Modern World Economy)
