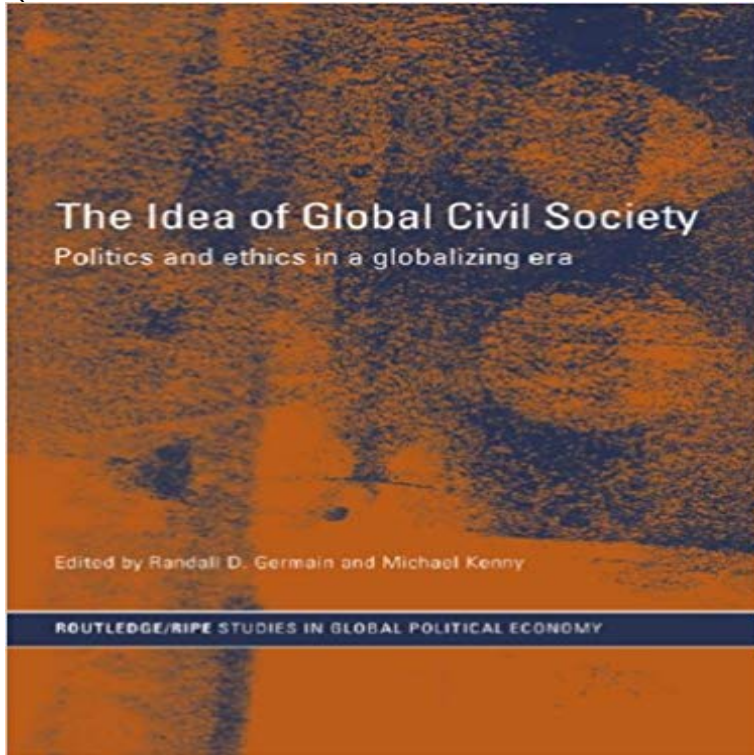


## The Idea of Global Civil Society: Ethics and Politics in a Globalizing Era (RIPE Series in Global Political Economy)
