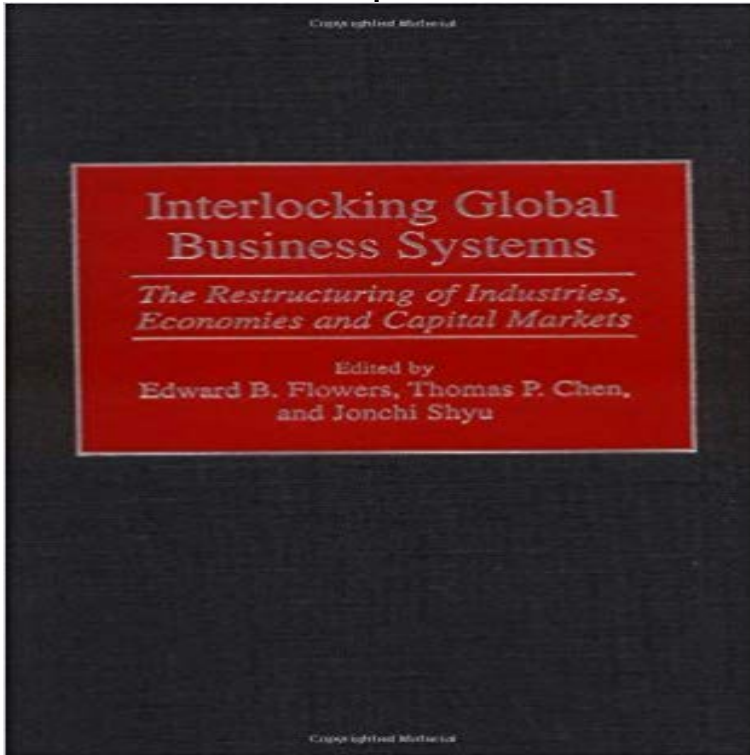


# Interlocking Global Business Systems: The Restructuring of Industries, Economies and Capital Markets
