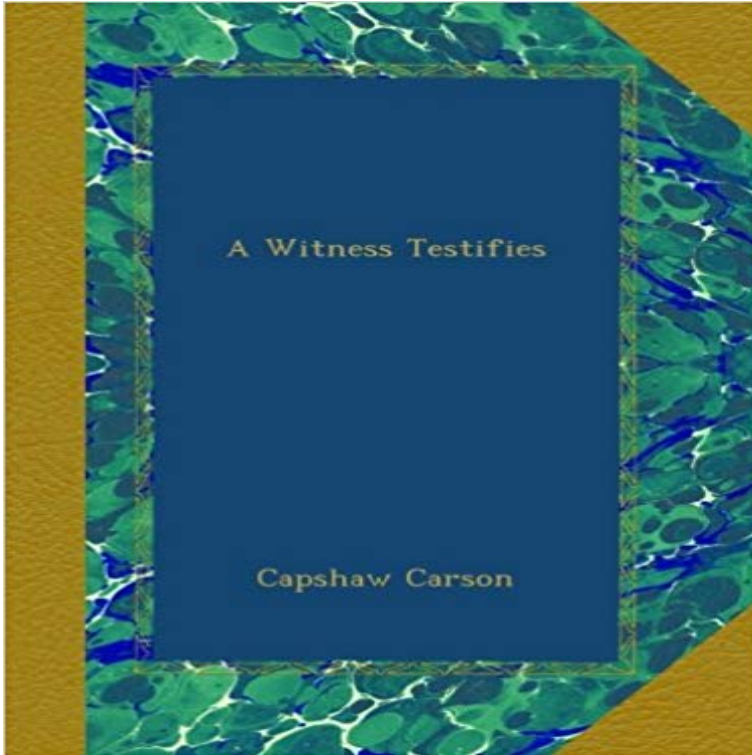


A Witness Testifies
