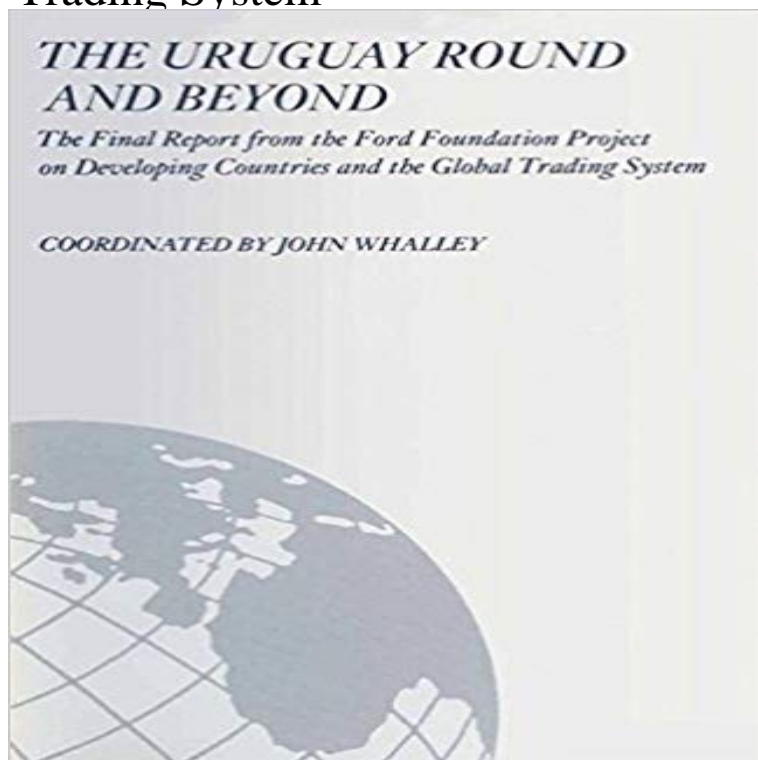


The Uruguay Round and Beyond: The Final Report from the Ford Foundation Supported Project on Developing Countries and the Global Trading System
